Membership Categories

Membership in the Builders Exchange is a company membership, with each member firm designating an "Active" or voting member. Additional employee memberships from a member firm are called "Associate Members," and they enjoy all rights of membership except voting on association issues.

All Active and Associate memberships are owned by the member company, not by an individual. Once a firm is approved for membership, only the company's Active Designee or President/CEO may authorize changes in the firm's individual members.

The honorary, non-voting category called "Senior Member" is reserved for individuals who are at least 60 years old and can substantiate their involvement at the Builders Exchange for at least 20 years.

Membership Costs

Every member firm of the Builders Exchange of Central Ohio pays the same annual fee for its Active company membership. Additional membership costs incurred by firms are for individuals who are added as Associate Members or Senior Members.

The application fee is \$100 per company and is a one-time fee, unless the firm's membership has lapsed for 12 months or more. In that case, the company must again pay an application fee to re-join the Builders Exchange. The application fee must accompany a firm's membership application for the application to be processed.

Active (company) annual membership dues for 2010 are \$735, and are pro-rated at the middle of the year.

Associate (additional individual) annual dues for 2010 are \$75, and are pro-rated in October.

Senior annual dues for 2010 are \$25, an amount which is not pro-rated.

Membership Process

1. This four-page application must be completed in full and signed by the applying firm's President, CEO, Managing Partner or Managing Member. (A faxed signature from the President or CEO is acceptable.)
2. By completing this application, the applicant agrees to abide by the standards listed herein.
3. Applying companies may be sponsored by a BX member firm, or by a member of the Builders Exchange staff.
4. A non-refundable application fee of \$100 must accompany this application.
5. Applicants will be notified in writing that their application has been processed.

Membership Standards

1. Invoice terms of all dues and other indebtedness to the Exchange are payable upon receipt, along with reasonable collection costs if necessary.
2. Applicants understand that membership in the Builders Exchange does not mean the member firm or its products are endorsed by the association.

While members are encouraged to indicate their affiliation and participation with the BX, [companies may not in any way state or imply that they have been endorsed by the Builders Exchange](#). (Exceptions are firms that have been selected in an established process by the Board of Directors as an endorsed service provider of the Exchange.)

3. Members in good standing are encouraged and authorized to use association-provided and approved official "BX Member" marks in advertising and promotional efforts, with the following guidelines:
 - Only BX-approved and provided marks may be used. Members must contact the Builders Exchange to receive copies and review the process for its approval on their documents.
 - In all cases, BX marks may only be used in conjunction with a member's own marks, and at a scale proportionally designed to indicate affiliation status. Members may not modify, amend or change the BX marks in any way. BX marks may not exceed 25% of the size of the member firm's marks.
 - The Builders Exchange reserves the right to determine appropriate use of its marks, and to deny requested use at the discretion of the BX Executive Director, acting for the Board of Directors.
 - At the request of the Executive Director, members will modify or discontinue use of BX marks as requested.
